Death Claims

No matter how prepared you might be – if you're here, it's a rough road you're on. First, know that there's support available. Many people engage the services of a solicitor to manage an estate.

Before you start the process of notifying organisations and submitting claims, you will need your loved ones Death Certificate. Generally, the funeral director will arrange this on your behalf however if this is not the case, you can find the details for registering the death and applying for a death certificate for your applicable state by following the links below:

Notifying Organisations

Once you have the death certificate, you can start notifying the relevant organisations and the following list, though not exhaustive, is a good place to start for notifications:

- Centrelink
- Australian Tax Office
- Banks
- Insurance companies
- Superannuation fund of the deceased
- Utility companies
- Transport Department
- The electoral commission

In most cases, when someone passes – you'll need to apply for probate.

<u>This link</u> to the QLD courts website could provide more clarity for you. In cases where insurance has been held inside super – instead of personally owned – the chance you'll need probate is significantly increased.

Unfortunately, it's not a super quick turnaround – maybe 4-8 weeks. You might get it done a little faster with a probate specialist – and if you'd like a recommendation in this area, please ask.
